

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Authorizing an Extension of Three Months to Complete
Governmental Operations Study)

RESOLUTION NO. 2000-130

1 **WHEREAS, Resolution No. 99-525 provides that "the Executive Branch of the Tohono O'odham**
2 **Nation in conjunction with the Judicial and Legislative Branches, together**
3 **undertake a study to be completed within six months that identifies methods for**
4 **addressing and preventing any potential, future shortfalls in funding for**
5 **government operations;" and**

6 **WHEREAS, the government operations study is in progress; and**

7 **WHEREAS, the Chairman of the Nation finds that an additional three months are required to**
8 **properly complete the governmental operations study; and**

9 **WHEREAS, the Chairman of the Nation finds and recommends that it is in the best interest of the**
10 **Nation to extend the six month deadline to complete the governmental operations**
11 **study by an additional three months.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**

- 13 1. **Accepts the recommendation of the Chairman of the Nation.**
14 2. **Approves and authorizes an extension of three months to complete the**
15 **governmental operations study referred to in Resolution No. 99-525.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day**
17 **of MARCH, 2000 at a meeting at which a quorum was present with a vote of 1,266.5 FOR; 660.8**
18 **AGAINST; 104.8 NOT VOTING; and 133.4 [04] ABSENT, pursuant to the powers vested in the Council**
19 **by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**




