**(Request Assistance and Support from Michael H. Trujillo M.D., M.P.H., Director, Indian Health Service Unit to establish a Contract with Dr. Kham Vay Ung in Evaluation, Treatment and Education to Prevent Limb Amputation for the Tohono O'odham Nation)**

**RESOLUTION NO. 2000-140**

1 **WHEREAS** the Tohono O'odham Nation is known to have the highest rate of Diabetes Mellitus  
2 in the world; and

3 **WHEREAS,** due to the high rate of Diabetes Mellitus, there is a high rate of limb Amputations on  
4 the Tohono O'odham Nation; and

5 **WHEREAS,** the Tohono O'odham Legislative Council has a keen interest and concern in reducing  
6 limb amputation for members; and

7 **WHEREAS,** the Legislative Council Oversight Committee on Health and Human Services, Tohono  
8 O'odham Executive Office, Tucson Area Office, and the Sells Service Unit staff on  
9 March 13, 2000 met to discuss Dr. Kham Vay Ung, D.P.M. contract status; and

10 **WHEREAS,** the Tucson Area Contracting office informed everyone that a rate quotation for  
11 professional health care services was sent to Dr. Kham Vay Ung, D.P.M. which is not  
12 a contract; and

13 **WHEREAS,** the Tohono O'odham Legislative Council still wants Indian Health Service, Sells  
14 Service Unit to establish a contract with Dr. Kham Vay Ung to provide on site clinical  
15 services.

16 **NOW, THEREFORE, BE IT RESOLVED,** that the Legislative Council:

- 17 1. Request assistance and support from Dr. Michael H. Trujillo, M.D., M.P.H.,  
18 Director Indian Health Service to assist the Tohono O'odham Nation to establish  
19 a contract with Kham Vay Ung through the Sells Service Unit for clinical services  
20 on site.

21 **BE IT FURTHER RESOLVED** that the Appropriations Committee is hereby authorized and directed  
22 to bring this request to the appropriate Agencies, Members and Committees of  
23 Congress.

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST. day**  
25 **of MARCH, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT,** pursuant to the powers vested in the Council by  
27 **Section 1(j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**






