Day of <u>APRIL</u>, <u>2000</u> at a meeting at which a quorum was present with a vote of <u>2,165.5</u> FOR; <u>-0-AGAINST</u>; <u>-0-NOT VOTING</u>; and <u>[03]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
