3		Nation to respond promptly to environmental contamination incidents and natural

5	WHEREAS,	the Investment Committee and the Budget and Finance Committee recommend	
6		transferring Two Hundred Thousand Dollars (\$200,000.00) from the IC007 account	
7		to the Environmental Trust Fund.	
8	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes	
9		and directs the Chairman of the Nation and his staff to transfer Two Hundred	
10		Thousand Dollars (\$200,000.00) from the IC007 account to the Environmental Trust	
11		Fund for use in response to environmental contamination incidents and natural	
12		disasters.
