**RESOLUTION NO. 2000-151**

1 **WHEREAS, the Executive Branch has advertised the controller position for the ten (10) months**  
2 **and to date there has been no qualified applicants for the position; and**

3 **WHEREAS, the Nation's Accounting Department needs the technical expertise to deal with the**  
4 **day to day operational issues; and**

5 **WHEREAS, the Executive Office of the Chairman proposes to contract for the controller services**  
6 **until a permanent selection is made; and**

7 **WHEREAS, it is necessary to pool salary savings from the Accounting Department, General**  
8 **Services Administration and Treasury Budgets to establish adequate funds in the**  
9 **professional services line item budget of the Executive Office of the Chairman; and**

10 **WHEREAS, the Chairman of the Nation has determined that it is in the best interest of the Nation**  
11 **to transfer funds from Accounting, General Services Administration and Office of the**  
12 **Treasury Fiscal Year 2000 Budgets into Executive Office professional services line**  
13 **item; and**

14 **WHEREAS, as a result of second quarter financial expenditure report the Executive Office of the**  
15 **Chairman has prepared the attached Budget Modification #2 to meet financial**  
16 **requirements; and**

17 **WHEREAS, the Budget and Finance Committee has reviewed and approved the Executive Office**  
18 **of the Chairman Budget Modification #2 as presented.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**  
20 **hereby approve the Executive Office of the Chairman Budget Modification #2.**

21 **BE IT FURTHER RESOLVED that the funds listed below are authorized to be transferred to the**  
22 **budget of the Executive Office of the Chairman:**
