

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization for FY 2000 Adult Care Group Home Modification #2)

RESOLUTION NO. 2000-159

1 **WHEREAS, the Tohono O'odham Nation is presently operating the P.L. 93-638 contract with the**
2 **Bureau of Indian Affairs under a six (6) year Master Contract with FY 2000 being the**
3 **fourth year; and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham**
5 **Nation and its members; and**

6 **WHEREAS, the Adult Care Group Home - Account # 10-1304 has been modified to decrease line**
7 **items to utilize funds in other line items; and**

8 **WHEREAS, the Adult Care Group Home budget modification also includes transfer of funds to**
9 **the Children's Home/DD Home FY 2000 budget construction line item to be utilized**
10 **in the FY 2000 Adult Care Group Home budget construction line item; and**

11 **WHEREAS, the program is requesting approval for the FY 2000 Adult Care Group Home budget**
12 **modification #2.**

13 **NOW, THEREFORE, BE IT RESOLVED:**

- 14 **1. It hereby approves and authorizes the FY 2000 Adult Group Home modification**
15 **#2 in accordance with the attached budget.**
- 16 **2. The Tohono O'odham Nation's Officials to wit: the Chairman is hereby authorizes**
17 **to negotiate and execute the contract.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH.**
19 **Day of APRIL, 2000 at a meeting at which a quorum was present with a vote of 2,005.5 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and 160.0 [07] ABSENT, pursuant to the powers vested in the Council**
21 **by Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
24 **18, 1934 (48 Stat. 984).**
