RESOLUTION NO. 2000-160

WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control Services
Program to help prevent the spread of the disease through community education,
prevention, early detection, comprehensive regimens and careful follow up with
individuals; and
WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control Services
Program has been provided in part through supplemental funding sources; and
WHEREAS, the Division of Community Health Services - Tuberculosis Control Services desires
to continue the services it provides to TB susceptible patients; and
WHEREAS, the Tohono O'odham Tuberculosis Control Services Program has received funding
from the State of Arizona, Department of Health Services for its program.
NOW, THEREFORE, BE IT RESOLVED:
1. That the Tohono O'odham Legislative Council hereby approves the proposal for
funding of the Tohono O'odham Tuberculosis Control Services Program from the
State of Arizona Department of Health Services and approves expenditures in
accordance with the attached budget.
2. That the duration of this contract shall be from July 01, 2000 and remain in effect
as long as the Arizona Department of Health Services agrees to fund the Tohono
O'odham Tuberculosis Control Services Program.
3. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman
and any designated Official are hereby authorized to negotiate and execute this
contract.
The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>05TH</u> . Day of <u>APRIL</u> , <u>2000</u> at a meeting at which a quorum was present with a vote of <u>1,833.7</u> FOR; <u>-0-AGAINST</u> ; <u>-0-NOT VOTING</u> ; and <u>331.8 [08]</u> ABSENT, pursuant to the powers vested in the Council by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
