

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2001 Division of Community Health Services/Tuberculosis Control**  
**Services Program Budget)**

**RESOLUTION NO. 2000-160**

1 **WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control Services**  
2 **Program to help prevent the spread of the disease through community education,**  
3 **prevention, early detection, comprehensive regimens and careful follow up with**  
4 **individuals; and**

5 **WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control Services**  
6 **Program has been provided in part through supplemental funding sources; and**

7 **WHEREAS, the Division of Community Health Services - Tuberculosis Control Services desires**  
8 **to continue the services it provides to TB susceptible patients; and**

9 **WHEREAS, the Tohono O'odham Tuberculosis Control Services Program has received funding**  
10 **from the State of Arizona, Department of Health Services for its program.**

11 **NOW, THEREFORE, BE IT RESOLVED:**

- 12 **1. That the Tohono O'odham Legislative Council hereby approves the proposal for**  
13 **funding of the Tohono O'odham Tuberculosis Control Services Program from the**  
14 **State of Arizona Department of Health Services and approves expenditures in**  
15 **accordance with the attached budget.**
- 16 **2. That the duration of this contract shall be from July 01, 2000 and remain in effect**  
17 **as long as the Arizona Department of Health Services agrees to fund the Tohono**  
18 **O'odham Tuberculosis Control Services Program.**
- 19 **3. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman**  
20 **and any designated Official are hereby authorized to negotiate and execute this**  
21 **contract.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH,**  
23 **Day of APRIL, 2000 at a meeting at which a quorum was present with a vote of 1,833.7 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and 331.8 [08] ABSENT, pursuant to the powers vested in the Council**  
25 **by Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**


