(Authorizing the Chairman of the Nation to Negotiate and Execute a P.L. 93-638 Self-Determination Construction Contract with the Indian Health Service for the Planning and Design of the Westside Health Center)

**RESOLUTION NO. 2000-162** 

1	WHEREAS,	the Tohono O'odham Nation ("Nation") has negotiated a joint funding project with
2		the Indian Health Service wherein the Indian Health Service will provide Three
3		Hundred Fifty Thousand Dollars (\$350,000) for planning and design, and the Tohono
4		O'odham Nation will provide approximately Eleven Million Dollars (\$11,000,000) for
5		construction of the Westside Health Center to better serve the health needs of the
6		Nation; and
7	WHEREAS,	the Nation and the Indian Health Service are negotiating a Public Law 93-638 Self-
8		Determination Construction Contract under Subpart J of the 638 regulations, under
9		which the Indian Health Service will pay the \$350,000 to the Nation in one lump sum
10		to be applied to the planning and design phase of the joint project; and
11	WHEREAS,	the Legislative Council has reviewed the proposed contract in the form distributed
12		to Council members today.
13	NOW. THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
14	,	Public Law 93-638 Self-Determination Construction Contract for the Westside
15		Medical Center and authorizes the Chairman of the Nation to further negotiate the
16		contract and to execute the contract substantially in the form distributed to the
17		Legislative Council.
