7	agreement funds for Fiscal Year 2000; and
8	WHEREAS, there is a need to add a new budget line item, #750 Capital Equipment, to cover costs
9	and purchases of additional emergency response equipment for the Tohono
10	O'odham Fire Department.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
12	approves the Superfund CORE budget modification of additional funds and a line
13	item.
14	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
15	Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official
16	are hereby authorized to negotiate and execute the grant, provide however, that any
17	amendments affecting the funding or funding levels of the grant shall be submitted
18	for further prior approval .
19	BE IT FINALLY RESOLVED that the Legislative Council approves the attached budget and
20	authorizes expenditure of the Superfund CORE Program budget.
