

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Budget Modification for the Superfund CORE Program and authorization
of expenditure in accordance with the attached Budget)

RESOLUTION NO. 2000-167

1 **WHEREAS, the United States Environmental Protection Agency (USEPA), Region IX approved**
2 **the grant application in the amount of \$80,000.00 submitted by the Tohono**
3 **O'odham Nation to continue the Superfund CORE Program; and**

4 **WHEREAS, there are funds available from the previous fiscal years 1998 & 1999 in the amount**
5 **of \$59,561.03 which can be carried over into the fiscal year 2000 budget; and**

6 **WHEREAS, the Superfund CORE Program budget would total \$139,561.03 of cooperative**
7 **agreement funds for Fiscal Year 2000; and**

8 **WHEREAS, there is a need to add a new budget line item, #750 Capital Equipment, to cover costs**
9 **and purchases of additional emergency response equipment for the Tohono**
10 **O'odham Fire Department.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
12 **approves the Superfund CORE budget modification of additional funds and a line**
13 **item.**

14 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official**
16 **are hereby authorized to negotiate and execute the grant, provide however, that any**
17 **amendments affecting the funding or funding levels of the grant shall be submitted**
18 **for further prior approval .**

19 **BE IT FINALLY RESOLVED that the Legislative Council approves the attached budget and**
20 **authorizes expenditure of the Superfund CORE Program budget.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
22 **of APRIL, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**
