**(In Support of Employment Assistance Program FY-2000, Budget Mod. II)**

**RESOLUTION NO. 2000-197**

1 **WHEREAS, the Tohono O'odham Nation, through the Employment Assistance Program has been**  
2 **successfully providing counseling and financial assistance to eligible Tohono**  
3 **O'odham to attend vocational training; and**

4 **WHEREAS, the Employment Assistance Program has a final allocation increase for FY-2000, in**  
5 **the amount of \$2,979.00; and**

6 **WHEREAS, the FY-2000 Employment Assistance Program budget modification II also reflects a**  
7 **line item increase.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the**  
9 **Employment Assistance Program budget modification # II reflecting the FY - 2000**  
10 **final allocation in the amount of \$350,372.00.**

11 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH day**  
12 **of MAY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;**  
13 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
14 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
15 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


