5	\$27,000.00; and
6	WHEREAS, the total allocated is not sufficient to address the needs of the Advocate Program for
7	conflict attorney services for FY 2000; and
8	WHEREAS, the Executive Office of the Nation has agreed to provide additional funding o
9	\$85,000.00 from its contingency fund account (01.1003.780) to supplement the
10	payment of each attorney's fees and expenses incurred in the delivery of lega
11	services on behalf of the Advocate Program; and
12	WHEREAS, it is projected that Attorney will incur an additional \$32,500.00 in fees and expense
13	throughout the remainder of FY 2000.
14	NOW, THEREFORE, BE IT RESOLVED THAT:
15	1. The Tohono O'odham Legislative Council ratifies and approves the
16	"Amendment to Tohono O'odham Attorney Contract" for David M. Juarez in the
17	form attached hereto, for the period October 1, 1999, through September 30
18	2000, in the amount of \$32,500.00 in additional funding for a total amount no
19	to exceed \$59,500.00 for such period.
20	2. The additional funding of \$32,500.00 shall be provided from Executive Offices
21	contingency fund account 01.1003.780.
