

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Contract Amendment for Attorney David M. Juarez)

RESOLUTION NO. 2000-204

1 **WHEREAS, the Tohono O'odham Legislative Council, in Resolution No. 99-603 previously**
2 **approved contracts for David M. Juarez, Lawrence O. Boswell and David K. Kovalik**
3 **("Attorney") to serve as conflict attorneys for the Advocate Program for FY 2000; and**

4 **WHEREAS, the maximum compensation and reimbursement for each Attorney was set at**
5 **\$27,000.00; and**

6 **WHEREAS, the total allocated is not sufficient to address the needs of the Advocate Program for**
7 **conflict attorney services for FY 2000; and**

8 **WHEREAS, the Executive Office of the Nation has agreed to provide additional funding of**
9 **\$85,000.00 from its contingency fund account (01.1003.780) to supplement the**
10 **payment of each attorney's fees and expenses incurred in the delivery of legal**
11 **services on behalf of the Advocate Program; and**

12 **WHEREAS, it is projected that Attorney will incur an additional \$32,500.00 in fees and expenses**
13 **throughout the remainder of FY 2000.**

14 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 15 1. **The Tohono O'odham Legislative Council ratifies and approves the**
16 **"Amendment to Tohono O'odham Attorney Contract" for David M. Juarez in the**
17 **form attached hereto, for the period October 1, 1999, through September 30,**
18 **2000, in the amount of \$32,500.00 in additional funding for a total amount not**
19 **to exceed \$59,500.00 for such period.**
- 20 2. **The additional funding of \$32,500.00 shall be provided from Executive Offices'**
21 **contingency fund account 01.1003.780.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH,**
23 **Day of MAY, 2000 at a meeting at which a quorum was present with a vote of 2,165,5 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
