8	WHEREAS,	the Executive Office of the Nation has agreed to provide additional funding of				
9		\$85,000.00 from its contingency fund account (01.1003.780) to supplement the				
10		payment of each attorney's fees and expenses incurred in the delivery of legal				
11		services on behalf of the Advocate Program; and				
12	WHEREAS,	it is projected that Attorney will incur an additional $\$30,000.00$ in fees and expenses				
13		throughout the remainder of FY 2000.

16		"Amendment to Tohono O'odham Attorney Contract" for Lawrence O. Boswell				
17		in the form attached hereto, for the period October 1, 1999, through September				
18		30, 2000, in the amount of $\$30,000.00$ in additional funding for a total amount				
19		not to exceed \$57,000.00 for such period.				
20		2. The additional funding of \$30,000.00 shall be provided from Executive Offices'
