14	WHEREAS,	the Domestic Affairs Committee recommends approval by the Legislative Council
15		of an Attorney Contract with the Attorneys on such terms.
16	NOW, THER	REFORE, BE IT RESOLVED THAT:
17		1. The Tohono O'odham Legislative Council hereby approves an Attorney Contract
18		with the law firm of Quigley, Tang & Whitehill in the amount of \$353,750.00 for
19		the remainder of the fiscal year ending September 30, 2000, and in the form
20		attached hereto.
21		2. Funding for the Attorney Contract shall be provided under the operating budget
22		of the Office of Attorney General for fiscal year 1999, account number 1-4236-
23		810.
24		3. The Chairman of the Nation is authorized and directed to execute the Attorney
