7 **from the membership roll.**



11 **AGAINST; 104.8 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
12 **Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham**  
13 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the**  
14 **Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to**  
15 **Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
