

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation Employment & Training - Department of Labor - Comprehensive Service Plan and Budget Program Year 2000)

RESOLUTION NO. 2000-229

1 **WHEREAS, the Tohono O'odham Nation recognizes the end to federal legislation of the Job**
2 **Training Partnership Act and the creation and implementation of the Workforce**
3 **Investment Act; and**

4 **WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has been renamed as the Tohono**
5 **O'odham Nation Employment & Training Program which will include all programs**
6 **formerly under JTPA/NEW/WtW; and**

7 **WHEREAS, the funding amount for the Department of Labor Comprehensive Service Plan and**
8 **Budget Program Year 2000 is \$ 458,356.00; and**

9 **WHEREAS, this budget is included in the program Comprehensive Service Plan which will**
10 **commence July 1, 2000 and will expire June 30, 2003.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council does hereby**
12 **approve the Department of Labor - Comprehensive Service Plan and Budget**
13 **Program Year 2000 Budget authorized for expenditure from July 1, 2000 until June**
14 **30, 2003 in the amount of \$ 458,356.00.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute**
17 **the contract, provided however, that any amendment affecting the funding or**
18 **funding levels of this contract shall be submitted for further prior approval by this**
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH.**
21 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**






