

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Tohono O'odham Nation Employment & Training - State of Arizona**  
**- Adult Budget Program Year 2000)**

RESOLUTION NO. 2000-231

1 WHEREAS, the Tohono O'odham Nation recognizes the end to federal legislation of the Job  
2 Training Partnership Act and the creation and implementation of the Workforce  
3 Investment Act; and

4 WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has been renamed as the Tohono  
5 O'odham Nation Employment & Training Program which will include all programs  
6 formerly under JTPA/NEW/WtW; and

7 WHEREAS, the funding amount for the State of Arizona - Adult Budget Program Year 2000 is  
8 \$133,453.00; and

9 WHEREAS, this budget will be amended when final allocations have been received from the State  
10 of Arizona and a contract will be completed when issued by the State of Arizona; and

11 WHEREAS, this budget will commence upon approval of this resolution or July 1, 2000, which  
12 ever comes first, and will expire June 30, 2002; and

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
14 approve the State of Arizona - Adult Program Year 2000 Budget authorized for  
15 expenditure from July 1, 2000 until June 30, 2003 in the amount of \$133,453.00.

16 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
17 Nation's Officials, to wit; the Chairman is hereby authorized to negotiate and execute  
18 the contract, provided however, that any amendment affecting the funding or  
19 funding levels of this contract shall be submitted for further prior approval by this  
20 Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH.  
22 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-  
23 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
24 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
25 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
27 18, 1934 (48 Stat. 984).




