

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Grant Award from the Tucson-Pima Arts Council for the Venito Garcia Library)

RESOLUTION NO. 2000-233

1 WHEREAS, the Legislative Council of the Tohono O'odham Nation has traditionally supported
2 the library activities of the Venito Garcia Library and it accepts the grant award from
3 the Tucson-Pima Arts Council to aid in a summer reading program centered around
4 reading and making books in O'odham.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does
6 hereby approve the proposed budget of \$2,000.00 dollars for said summer reading
7 program assistance and authorizes the expenditure of funds in accordance with the
8 attached budget by the Venito Garcia Library.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH
11 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-
12 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
13 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
14 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
16 18, 1934 (48 Stat. 984).


