

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Modification No. 2 to FY 2000 Budget of the Office of Attorney General)**

RESOLUTION NO. 2000-234

1 **WHEREAS, pursuant to Resolution 99-528, the fiscal year 2000 budget of the Office of Attorney**
2 **General was approved by the Legislative Council as part of the Executive Branch**
3 **budget for such fiscal year; and**

4 **WHEREAS, an offer of summer employment as Legal Intern has been made and accepted by**
5 **Eddie Garcia, a second year O'odham law student at the University of New Mexico,**
6 **effective June 12, 2000 through August 18, 2000 and contingent on approval of**
7 **Modification No. 2; and**

8 **WHEREAS, Modification No. 2 adds a staff position not included in the Office budget for fiscal**
9 **year 2000, requiring approval of the Legislative Council; and**

10 **WHEREAS, the budget adjustment in Modification No. 2 is funded entirely within amounts in the**
11 **Office budget approved by the Legislative Council for fiscal year 2000; and**

12 **WHEREAS, the Domestic Affairs Committee and Budget and Finance Committee recommend**
13 **approval of Modification No. 2 by the Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
15 **approves Modification No. 2 to the fiscal year 2000 budget of the Office of Attorney**
16 **General, in the form attached hereto.**




