

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Creation of a Dedicated Revenue Account for the Deposit of Funds
Received by the Cultural Affairs Program)

RESOLUTION NO. 2000-240

1 **WHEREAS, the Tohono O'odham Nation recognizes the need to protect, preserve and manage**
2 **cultural resources on its lands; and**

3 **WHEREAS, the Tohono O'odham Nation passed an Archaeological Resources Protection**
4 **Ordinance (06-84) for the protection and preservation of archaeological resources**
5 **historically associated with traditional or sacred values and beliefs important to the**
6 **O'odham, and of the physical site, location or context in which archaeological**
7 **resources are found; and**

8 **WHEREAS, the Tohono O'odham Legislative Council established the Cultural Affairs Program**
9 **in 1997 and has continued to provide budget support for the program for FY 1997-**
10 **2000; and**

11 **WHEREAS, establishing a dedicated revenue account will provide a base of funding for Program**
12 **operations from sources other than the Nation's General Fund.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
14 **authorizes:**

- 15 **1. the establishment of a dedicated revenue account for the Cultural Affairs**
16 **Program in which all funds obtained by the Program from outside sources shall**
17 **be deposited;**
- 18 **2. the Cultural Affairs Program to expend funds in this dedicated revenue account**
19 **for operational purposes consistent with approved budgets.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH,**
21 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**




