1 **WHEREAS, the Sif Oidak District was allocated a \$500,000 supplemental budget; and**
2 **WHEREAS, the Sif Oidak District is still in the ongoing process of expending the remainder of the**
3 **budget.**
4 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
5 **hereby grant the Sif Oidak District an extension on the \$500,000 supplement budget**
6 **from June 30, 2000 - July 31, 2000.**

8 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH,**
9 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
10 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
11 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
12 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
13 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
14 **18, 1934 (48 Stat. 984).**
