RESOLUTION NO. 2000-247

1 **WHEREAS, pursuant to Legislative Council Resolution No. 98-244, the Computer Network**
2 **Expansion three year grant was funded by the Health Resource and Service**
3 **Administration (HRSA) and will expire on August 31, 2000; and**

4 **WHEREAS, the Nation through the Department of Human Services has benefitted from the**
5 **establishment and development of a patient case management, coordination of**
6 **services and fiscal integration through third party billing; and**

7 **WHEREAS, the development and planning needs to continue for the provider Network for**
8 **improved patient care, communication and technical assistance; and**

9 **WHEREAS, the Computer Expansion grant expires August 31, 2000 and there remains thirty (30)**
10 **days, starting September 01, 2000 to September 30, 2000 that salaries and fringe**
11 **benefits for two positions will need to be funded for Information, Technology and**
12 **Systems supplemental budget; and**

13 **WHEREAS, the Department of Human Services does not have funds to support the position's**
14 **salaries and fringe benefits due to different funding cycles.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve to utilize the Employee Reserve Account as the funding source for the**
17 **Information, Technology and Systems Program in the amount of \$6,649.17 to pay for**
18 **the salaries and fringe benefits of two positions for the period of one month starting**
19 **September 01, 2000 to September 30, 2000.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.**
22 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
25 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


