

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Budget Amendment to Resolution #99-528 FY 2000 Senior Services Base Budget)**

**RESOLUTION NO. 2000-248**

1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 99-528 in which**  
2 **\$478,001.65 was allocate to the Senior Services Program operations, and has been**  
3 **prepared to reflect the market and longevity for all Executive Branch employees as**  
4 **authorized by the Council; and**  
5 **WHEREAS, the budget presented at the time of appropriation was in the sum of \$478,001.65; and**  
6 **WHEREAS, the Division of Senior Services has developed and presented a budget amendment**  
7 **to incorporate additional funds of \$1,151.46 from the Human Resource Employee**  
8 **Classified Reserve Account #01-3006 and to include obligating salary savings to**  
9 **existing line items to cover operational expenses; and**  
10 **WHEREAS, the budget was reviewed by the Budget and Finance and the Oversight Committee.**  
11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
12 **hereby approves the budget amendment to incorporate the additional funds of**  
13 **\$1,151.46, from the Human Resource Employee Classified Reserve Account #01-3006,**  
14 **and to include modifying the salary savings to cover operational expenses to support**  
15 **the Senior Services Program, and further authorizes the expenditures of \$479,153.00**  
16 **according to the attached amended budget.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.**  
18 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 1,957.4 FOR; -0-**  
19 **AGAINST; 208.1 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
20 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
21 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
23 **18, 1934 (48 Stat. 984).**


