

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amendment to the FY 2000 Inter-Tribal Council of Arizona Women Infants,
& Children (WIC) Program Base Budget)

RESOLUTION NO. 2000-249

1 WHEREAS, the Tohono O'odham Nation has provided preventive health care for Women,
2 Infants, and Children during fiscal year 2000; and

3 WHEREAS, the Inter-Tribal Council of Arizona receives funds from the United States
4 Department of Agriculture for programs designed to benefit Women, Infants, &
5 Children; and

6 WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with
7 Inter-Tribal Council of Arizona to fund and operate the Women, Infants, & Children
8 Program; and

9 WHEREAS, due to a decrease in the ITCA/WIC agreement, based on current caseload of less than
10 a 1,000 participants, a decrease of funding to \$106,500.00 from \$142,140.04 will
11 reflect a modification to the FY 2000 tribal budget; and

12 WHEREAS, should there be an increase in caseload, additional funds may be made available by
13 Inter-Tribal Council of Arizona due to funding availability; and

14 WHEREAS, a budget modification is submitted for review and approval by the Department of
15 Human Services, Division of Community Health Services.

16 NOW, THEREFORE, BE IT RESOLVED,

- 17 1. That the Tohono O'odham Legislative Council hereby approves the attached
18 budget modification.
- 19 2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice-Chairman
20 and any designated Official are hereby authorized to negotiate and execute this
21 contract.

22 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.
23 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-
24 AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
25 Section 1 (d) (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
26 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
27 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
28 18, 1934 (48 Stat. 984).


