

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2000 Division of Community Health Services/Women, Infants, & Children
(WIC) Program Tribal Base Budget Modification #1)

RESOLUTION NO. 2000-250

1 WHEREAS, the Tohono O'odham Nation has preventive health care for women, infants, and
2 children during fiscal year 2000; and

3 WHEREAS, funding for the operation of the Women, Infants, & Children (WIC) Program has been
4 provided in part through supplemental funding sources; and

5 WHEREAS, due to decrease in the ITCA/WIC funding agreement, the Women, Infants, and
6 Children (WIC) Program has modified FY 2000 Tribal Base Budget to increase the
7 salary line item to cover the Nutrition Specialist and WIC Administrator's salaries
8 for the remaining fiscal year; and

9 WHEREAS, a budget modification is submitted for review and approval by the Department of
10 Human Services, Division of Community Health Services.

11 NOW, THEREFORE, BE IT RESOLVED,

- 12 1. That the Tohono O'odham Legislative Council hereby approves the attached
13 budget modification.
- 14 2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman
15 and any designated Official are hereby authorized to negotiate and execute this
16 contract.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.
18 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0-
19 AGAINST; 128.1 NOT VOTING; and 02 ABSENT, pursuant to the powers vested in the Council by
20 Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
21 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
23 18, 1934 (48 Stat. 984).


