

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2000 Budget Modification #2 for the Division of Community Health Representative and Community Health)

RESOLUTION NO. 2000-251

1 WHEREAS, the Tohono O'odham Nation is presently operating the Divisions of Community
2 Health Representatives and Community Health Services (CHR/CHS) for FY 2000
3 under P.L. 93-638 Master Health Contract No. 249-96-0001 with the Indian Health
4 Service; and

5 WHEREAS, the Tohono O'odham Nation's Grants and Contract Office has notified the CHR/CHS
6 Divisions of carryover funds in the amount of \$930,091.77 available for obligation
7 under the master health contract; and

8 WHEREAS, a budget modification is submitted for review and approval by the CHR/CHS
9 Divisions to utilize carry over funds to cover the increase in operational cost line
10 items and to include the utilities and communication expense line items.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 12 1. It hereby approves and authorizes expenditures in accordance with the attached
13 budget modification #2 submitted by the CHR/CHS Divisions.
- 14 2. The Tohono O'odham Nation Officials to wit: the Chairman or Vice-Chairman
15 and or any designated official are hereby authorized to negotiate and execute
16 this contract and to expend funds when received.



23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
24 18, 1934 (48 Stat. 984).
