

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of \$174,656.60, a three year budget allocation from the proceeds of the
Phoenix Indian School Trust Fund distribution through the Inter-Tribal Council
of Arizona and Navajo Trust Fund as authorized by Public Law 100-969)**

RESOLUTION NO. 2000-253

1 **WHEREAS, the Tohono O'odham Nation was notified in November, 1999 by the Executive**
2 **Director of the Inter-Tribal Council of Arizona, Mr. John R. Lewis, that the Nation is**
3 **scheduled to receive its first distribution of the Arizona Inter-Tribal Trust Fund**
4 **distribution in the amount of \$400,000.00 in December, 1999 under Public Law 100-**
5 **969, Arizona Inter-Tribal and Navajo Trust Fund; and**

6 **WHEREAS, the amount of \$174,656.60 will be allocated to the Department of Human Services**
7 **Child Welfare Division; and**

8 **WHEREAS, by agreement with the Nation's Executive Office and Department of Human Services,**
9 **the Arizona Inter-Tribal Trust Fund will fund a Child Welfare Specialist position and**
10 **an Administrative Assistant position.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves:**

- 12 **1. The amount of \$174,656.60 to be allocated from the \$400,000.00 proceeds of the**
13 **Phoenix Indian School Trust Fund distribution to the Department of Human**
14 **Services Child Welfare Division.**
- 15 **2. The attached Department of Human Services proposal and budget funds a Child**
16 **Welfare Specialist and Administrative Assistant position with operational cost**
17 **in the amount of \$174,656.60 for a period of three years, budget modification**
18 **during the three years not to exceed \$174,656.60.**
- 19 **3. The Tohono O'odham Nation's officials to wit: the Chairman and Vice-Chairman**
20 **and any designated official are hereby authorized to negotiate, execute and**
21 **expend the grant.**
- 22 **4. That at the end of the three year budget term, the Child Welfare Specialist and**
23 **Administrative Assistant positions will be made a part of the base budget of the**
24 **Department of Human Services Child Welfare Division.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.**
26 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 1,798.35 FOR; 367.15**
27 **AGAINST; -0-NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**


