

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Appropriation Request for Additional Amount for Parenting Skills Training Program Fringe Benefits due to Salary Adjustment; Acct. #01-1301)**

RESOLUTION NO. 2000-254

1   **WHEREAS, the Tohono O'odham Department of Human Services has the primary responsibility**  
2                   **to provide prevention and intervention services to families at risk for child abuse**  
3                   **and neglect; and**

4   **WHEREAS, the Arizona Department of Economic Security provides funds for the development**  
5                   **and administration of child abuse and neglect prevention programs under specified**  
6                   **terms and conditions; and**

7   **WHEREAS, the Parenting Skills Training Program Tribal Subsidy provides 7% of the fringe**  
8                   **benefits for the Family Services Specialist funded by the Arizona Department of**  
9                   **Economic Security; and**

10 **WHEREAS, the Parenting Skills Training Program Tribal Subsidy appropriates additional**  
11                   **funding from the Employee Reserve Account in the amount of \$45.50 to cover the**  
12                   **difference in the fringe benefits for a total of \$1,703.19.**

13 **NOW, THEREFORE, BE IT RESOLVED:**

- 14                   **1. That the Tohono O'odham Legislative Council authorizes the appropriation of**  
15                   **additional funding from Employee Reserve Account in the amount of \$45.50 to**  
16                   **make up the difference for a total of \$1,703.19 for fringe benefits for the**  
17                   **Parenting Skills Training Program.**
- 18                   **2. That the Tohono O'odham Nation's Officials to wit: the Chairman, Vice-Chairman**  
19                   **and any designated official are hereby authorized to negotiate and execute the**  
20                   **subsidy.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH,**  
22 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and 04 ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**


