RESOLUTION NO. 2000-255

1 WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating  
2 the Division of Family Assistance Food Distribution Program under an FY 2000 Grant  
3 with the United States Department of Agriculture; and

4 WHEREAS, any amendments affecting the funding or funding levels of the grant shall be  
5 submitted for review and approval by the Tohono O'odham Legislative Council; and

6 WHEREAS, the Food Distribution Program has submitted a budget modification, to include line  
7 item 721 Supplies Other back into USDA budget and redirect money to help cover  
8 cost of other line items, for review and approval.

9 NOW, THEREFORE, BE IT RESOLVED BY THE TOHONO O'ODHAM LEGISLATIVE COUNCIL

10 1. It hereby approves and authorizes budget modification number one and  
11 authorizes expenditure in accordance with the attached budget.

12 2. The Tohono O'odham Nation's Officials to wit: the Chairman and Vice-Chairman  
13 and any designated official are hereby authorized to negotiate and execute the  
14 contract.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH  
16 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-  
17 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by  
18 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
19 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
21 18, 1934 (48 Stat. 984).
