RESOLUTION NO. 2000-256

1 WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating
2 the Division of Family Assistance Food Distribution Program under an FY 2000 Grant
3 with the United States Department of Agriculture; and

4 WHEREAS, any amendments affecting the funding or funding levels of the grant shall be
5 submitted for review and approval by the Tohono O'odham O'odham Legislative
6 Council; and

7 WHEREAS, the Food Distribution Program has submitted a One Time funding budget for review
8 and approval.

9 NOW, THEREFORE, BE IT RESOLVED BY THE TOHONO O'ODHAM LEGISLATIVE COUNCIL that:

- 10 1. It hereby approves and authorizes the One Time Funding budget and authorizes
11 expenditure in accordance with the attached budget.
- 12 2. The Tohono O'odham Nations's Officials to wit: the Chairman and Vice-Chairman
13 and any designated official are hereby authorized to negotiate and execute the
14 contract.


15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH,

18 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
19 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
20 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
21 18, 1934 (48 Stat. 984).
