

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**

**(Approval of FY 2000 Division of Health Transportation Services Budget  
Amendment #1 of \$269,479.33 for June 01 through September 30, 2000)**

**RESOLUTION NO. 2000-258**

1 **WHEREAS, the Tohono O'odham Nation is currently providing medically necessary**  
2 **transportation to members regardless of ability to pay; and**

3 **WHEREAS, the health transportation for dialysis and non-emergency clients is currently being**  
4 **provided in the San Xavier District by two drivers; and**

5 **WHEREAS, it has become evident that a full health transportation services team be established**  
6 **in the San Xavier District to provide adequate health transportation services; and**

7 **WHEREAS, the Division of Health Transportation Services has sufficient funds deposited with**  
8 **the Nation's Accounting Department to cover the proposed budget amount; and**

9 **WHEREAS, the Division of Health Transportation Services requests that this proposed budget**  
10 **amount of \$269,479.33 be incorporated as part of the Health Transportation Services**  
11 **base budget amount; and**

12 **WHEREAS, the Division of Health Transportation Services has amended the FY 2000 budget**  
13 **identifying the additional positions needed to provide a more adequate health**  
14 **transportation network; and**

15 **WHEREAS, a budget amendment has been submitted for review and approval by the**  
16 **Department of Human Services for the Division of Health Transportation Services.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

18 **1. It hereby approves the attached budget as submitted as an amendment to the FY**  
19 **2000 Health Transportation Services budget utilizing 3<sup>rd</sup> Party Reimbursement**  
20 **funds.**

21 **2. It hereby approves the proposed budget amendment be incorporated as part of**  
22 **the Health Transportation Services base budget for FY 2001.**

23 **3. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman**  
24 **and any designated Official is hereby authorized to negotiate and execute**  
25 **contracts and expend funds associated with this budget.**

26 **4. All future 3<sup>rd</sup> Party Reimbursements Funds obtained by the Division of Health**  
27 **Transportation Services shall continue to be applied to the Program's base**  
28 **budget and utilized for program operations.**

7 18, 1934 (48 Stat. 984).


