3 **638 Master Health Contract with the Public Health, Indian Health Services; and**

4 **WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance**
5 **Abuse - Community Base Prevention Training Project of non-recurring funds made**
6 **available by IHS modification number 47 and a budget modification is submitted for**
7 **review and approval by the Department of Human Services.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 9 **1. It hereby approves and authorizes expenditures in accordance with the attached**
10 **budget modification #1 submitted by the Department of Human Services.**
- 11 **2. The Tohono O'odham Nation's Officials to wit: the Chairman and Vice Chairman**
12 **and any designated official are hereby authorized to negotiate and execute the**
13 **contract.**

17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**
