**RESOLUTION NO. 2000-262**

1 **WHEREAS, the Tohono O'odham Nation Department of Human Services is presently operating**  
2 **the Division of Alcoholism and Substance Abuse Program Component under P.L. 93-**  
3 **638 Master Health Contract with the Public Health, Indian Health Services; and**

4 **WHEREAS, the Grants and Contracts Office has notified the Division of Alcoholism & Substance**  
5 **Abuse Program of non-recurring funds made available by IHS modification number**  
6 **47 and a budget modification is submitted for review and approval by the**  
7 **Department of Human Services.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 9           1. **It hereby approves and authorizes expenditures in accordance with the attached**  
10           **budget modification #2 submitted by the Department of Human Services.**
- 11           2. **The Tohono O'odham Nation's Officials to wit: the Chairman and Vice Chairman**  
12           **and any designated official are hereby authorized to negotiate and execute the**  
13           **contract.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.**  
15 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0-**  
16 **AGAINST; -0- NOT VOTING; and 128.1 [03] ABSENT, pursuant to the powers vested in the Council**  
17 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**


