**RESOLUTION NO. 2000-263**

1 **WHEREAS, the Tohono O'odham Nation is presently operating the Project 2000 under a Tribal**  
2 **Base Budget; and**  
3 **WHEREAS, the budget modification is necessary to address program and service needs; and**  
4 **WHEREAS, a budget modification has been submitted which does not change the funding level,**  
5 **but includes new line items and modifies other line item amounts to address current**  
6 **needs.**  
7 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
8 **approve the amendment to the Project 2000 and authorize expenditures in**  
9 **accordance with the attached budget modification.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.**  
11 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 1,880.6 FOR; -0-**  
12 **AGAINST; -0- NOT VOTING; and 284.9 [07] ABSENT, pursuant to the powers vested in the Council**  
13 **by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
16 **18, 1934 (48 Stat. 984).**


