

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2001 Elderly Title III B, C-1 and C-2 Proposal July 01, 2000 - June 30, 2001)

RESOLUTION NO. 2000-264

1 WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly
2 members of the Nation; and

3 WHEREAS, funding for the operation of the Elderly Program has been made possible in part by
4 Title III of the Older American's Act of 1965 as amended, through the Administration
5 of the Inter-Tribal Council of Arizona; and

6 WHEREAS, the services provided to elderly members has been beneficial and services continue
7 to be necessary to provide nutritional and social support; and

8 WHEREAS, the Elderly Program has prepared a proposal for FY 2001 Title III funding to provide
9 nutritional and social support services to eligible elderly members.

10 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:

- 11 1. That it hereby approves the proposal for Title III funding for the Elderly Program
12 to continue to provide such services it has proposed per attachments in light of
13 the requirements and regulations.
- 14 2. That the Nation has been informed by Inter-Tribal Council on Aging that the
15 budget period for this grant for FY 2001 will be from July 01, 2000 through June
16 30, 2001.
- 17 3. That the Tohono O'odham Nation officials, to wit: The Chairman is hereby
18 authorized to negotiate and execute the grant, provided however, that any
19 amendments affecting the funding or funding levels of this contract shall be
20 submitted for further prior approval by this Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.
22 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0-
23 AGAINST; -0- NOT VOTING; and 128.1 [04] ABSENT, pursuant to the powers vested in the Council
24 by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
25 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
27 18, 1934 (48 Stat. 984).


