1 WHEREAS, Low Income Home Energy assistance funds have been made available to the Tohono 2 O'odham Nation for FY 2001 through the State of Arizona, Department of Commerce; 3 and 4 WHEREAS, the Tohono O'odham Nation does meet the eligibility requirements to operate a Low 5 Income Home Energy Assistance Program; and 6 WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY 2001 Low 7 Income Home Energy Assistance funds to assist eligible families with utility 8 assistance; and 9 WHEREAS, the Tohono O'odham Nation does desire to secure funding for provision of services 10 during fiscal year 2001; and 11 WHEREAS, the Tohono O'odham Department of Human Services has submitted for review and 12 approval a scope of work and budget that will conform to the eligibility criteria set 13 for in the funding and reporting regulations. 14 NOW, THEREFORE, BE IT RESOLVED, 15 That the Tohono O'odham Legislative Council does hereby authorize the 16 officials of the Tohono O'odham Nation to submit a request for Low Income 17 Home Energy Assistance Funding from the State of Arizona, Department of 18 Commerce and authorizes expenditures in accordance to the attached budget. 19 That the duration of the grant shall be from July 01, 2000 through June 30, 2001. 20 That the Tohono O'odham Nation Officials, to wit: the Chairman and Vice-21 Chairman and any designated Official are hereby authorized to negotiate and 22 execute the contract. 23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. 24 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-25 AGAINST; -0-NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by 26 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the 27 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant 28 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 29 18, 1934 (48 Stat. 984). 30 TOHONO O'ODHAM LEGISLATIVE COUNCIL 31 32 Dennis Ramon, Legislative Chairman 33 34 9 day of June , 2000
