(Approval of Tohono O'odham Department of Human Services-Division of Psychological Services-FY 2000 IHS Contract 249-96-001 Modification #2, Account #10-1440)

RESOLUTION NO. 2000-271

1 WHEREAS, the Tohono O'odham Nation is presently operating the Tohono O'odham
2 Psychological Services through a P.L. 93-638 contract and Tribal funding; and

3 WHEREAS, the Psychological Services Division has received notification from Tohono O'odham
4 Nation Grants and Contracts of IHS unspent monies through the termination of the
5 IPA and MOA with IHS in the amount of \$96,024.00; and

6 WHEREAS, the Psychological Services Division has produced a budget modification using IHS
7 FY 97 and FY 98 monies to cover operational expenses and to purchase office
8 equipment and supplies for FY 2000.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
10 approves the attached FY 2000 Psychological Services IHS Modification #2.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH.
12 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-
13 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
14 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
15 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
17 18, 1934 (48 Stat. 984).
