

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Approval of FY 2000 TODHS Revenue Funds Modification #1)

RESOLUTION NO. 2000-273

1 WHEREAS, the TOPS Program has been billing AHCCCS for services rendered and has generated  
2 income in excess of \$12,000 per month; and

3 WHEREAS, the Tohono O'odham Nation is currently operating the Tohono O'odham  
4 Psychological Services Day Treatment Program for the Seriously Mentally Ill Tas  
5 Tonlik Ki Day Program; and

6 WHEREAS, the TOPS Program has submitted a budget modification reducing the TODHS  
7 Revenue Funds by covering salaries cost with SMI Grant carry over.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby  
9 approves the attached TODHS Revenue Funds Modification #1 reducing the  
10 budgeted amount by \$49,816.46.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH.  
12 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-  
13 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by  
14 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
15 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
16 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
17 18, 1934 (48 Stat. 984).


