

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Creation of a Dedicated Revenue Account for the Deposit of Funds
Received by the Wildlife and Vegetation Management Program)**

RESOLUTION NO. 2000-277

1 **WHEREAS, the Tohono O'odham Nation recognizes the need to manage natural resources on its**
2 **lands for the benefit of its members and has identified this need in Article XVIII of**
3 **its Constitution; and**

4 **WHEREAS, the Tohono O'odham Legislative Council approved salaries for two employees to**
5 **establish a Wildlife and Vegetation Management Program (the Program) within the**
6 **Natural Resources Department by approving the FY 1999 Executive Branch**
7 **Supplemental Budget (Resolution No. 99-175) and subsequently the FY 2000**
8 **Executive Branch budget, which also established a general fund account for the**
9 **Program (Resolution No. 99-528); and**

10 **WHEREAS, one of the Program's stated objectives is to "seek funding from outside sources to**
11 **enhance its ability to meet its goals and reduce the Nation's financial commitment**
12 **for its operation"; and**

13 **WHEREAS, establishing a dedicated revenue account will:**

- 14 **1) Provide a base of funding for Program operations from sources other than the**
15 **Nation's General Fund.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **authorizes:**

- 18 **1) the establishment of a dedicated revenue account for Wildlife and Vegetation**
19 **Management Program in which all funds obtained by the Program from outside**
20 **sources shall be deposited;**
21 **2) the Wildlife and Vegetation Management Program to expend funds in this**
22 **dedicated revenue account for operational purposes consistent with approved**
23 **budgets.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH.**
26 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 1,877.0 FOR; 128.1**
27 **AGAINST; 160.0 NOT VOTING; and 07 ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
