

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 2000-211, "Approving FY 2000 Tohono O'odham Wellness**  
**Conference Budget")**

**RESOLUTION NO. 2000-280**

1 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No.2000-211,**  
2 **approving the FY 2000 Wellness Conference Budget in the amount of \$70,300; and**  
3 **WHEREAS, pursuant to Resolution No. 2000-211 the amount of \$70,300.00 was to be**  
4 **appropriated from the Executive, Legislative, and Judicial Branch; and**  
5 **WHEREAS, it has been determined there is savings from the FY 2000 Elder Conference budget**  
6 **that can be appropriated to the Wellness Conference; and**  
7 **WHEREAS, the Wellness Conference has submitted a budget in the amount of \$40,000; and**  
8 **WHEREAS, the budget of \$40,000 has been reviewed by the Health and Human Services**  
9 **Committee and the Budget and Finance Committee.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 11 **1. The FY 2000 Tohono O'odham Wellness Conference Budget is approved in the**  
12 **amount of \$40,000 and is authorized to be expended accordingly.**
- 13 **2. The budget as appropriated is further authorized to become part of the base**  
14 **funding for the Tohono O'odham Wellness Conference.**
- 15 **3. The Chairman and Vice Chairman of the Nation are authorized to execute**  
16 **contracts associated with this budget.**
- 17 **4. \$40,000.00 from the savings of the FY 2000 Elder Conference budget has been de-**  
18 **obligated from the Elder Conference budget pursuant to Resolution No.2000-279**  
19 **and appropriated to the Wellness Conference budget.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH.**  
21 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 1,894.15 FOR; 143.25**  
22 **AGAINST; 128.1 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
24 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
