

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Submission and Negotiation of the Fiscal Year 2001 Annual Funding
Agreement to the Indian Self-Determination Act Master Contract with the
INDIAN HEALTH SERVICE)

RESOLUTION NO. 2000-283

1 WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the
2 Indian Health Service pursuant to the authority conferred to the Nation by the
3 Indian Self-Determination Act, as amended; and
4 WHEREAS, the Tohono O'odham Nation desires to continue operation of such functions and
5 commence operation of certain new programs, functions, services and activities
6 currently performed by the Indian Health Service, including Emergency Medical
7 Services.
8 NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Nation is authorized to submit the
9 attached Fiscal Year 2001 Annual Funding Agreement to the Indian Health Service
10 including contracting for the new program of Emergency Medical Services and to
11 negotiate maximum funding and acceptance by the Indian Health Service of the
12 terms and conditions contained herein.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH.
15 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 1,862.4 FOR; -0-
16 AGAINST; 143.1 NOT VOTING; and 160.0 [02] ABSENT, pursuant to the powers vested in the Council
17 by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
18 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat. 984).
