

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Tohono O'odham Department of Human Services-Division of Psychological Services-FY 2001 TODHS SMI Program to utilize Third Party Billing Revenues Funds)

RESOLUTION NO. 2000-285

1 **WHEREAS, the Tohono O'odham Nation is currently operating the Tohono O'odham**
2 **Psychological Services Treatment Program for the Seriously Mentally Ill Tas Tonlik**
3 **Ki Day Program through a tribal subsidy, revenue funds and I.H.S. extension grant**
4 **utilizing carryover monies; and**

5 **WHEREAS, the FY 2001 proposal is to continue to utilize tribal and revenue funding to cover the**
6 **SMI Day Program for the fiscal year (October 01, 2000 to September 30, 2001); and**

7 **WHEREAS, the program has prepared the FY 2001 SMI budget to use projected funds generated**
8 **through third party billing to cover the personnel expenses for the fiscal year**
9 **(October 01, 2000 to September 30, 2001) in the amount of \$154,922.86.**

10 **NOW, THEREFORE, BE IT RESOLVED:**

- 11 **1. That the Tohono O'odham Legislative Council hereby approves the FY 2001**
12 **TODHS Special Revenues Fund Budget at \$154,922.86 to cover personnel**
13 **expenses effective October 01, 2000 to September 30, 2001.**
- 14 **2. That the Department of Human Services requests waiver on Indirect Costs for**
15 **this Special Revenue budget to cover the personnel expenditures for the SMI Day**
16 **Program.**
- 17 **3. That the Tohono O'odham Nation's Official, to wit: the Chairman, Vice Chairman**
18 **and any designated Officer are hereby authorized to negotiate and execute the**
19 **proposal.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH.**
22 **Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,005.5 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and 160.0 [06] ABSENT, pursuant to the powers vested in the Council**
24 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
27 **18, 1934 (48 Stat. 984).**


