

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2001 Department of Human Services/Division of Community Health Services - Elder Health Care Initiative Proposal)**

RESOLUTION NO. 2000-286

1 WHEREAS, Legislative Council, through Resolution No. 97-265, approved a five-year project to  
2 develop and implement a Home Health Agency; and

3 WHEREAS, the Tohono O'odham Nation is presently developing a Home Health Agency under  
4 IHS Grant #ISH002103-02 with the Indian Health Services; and

5 WHEREAS, a budget for year four is submitted to continue the implementation of a Home  
6 Health Agency.

7 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that :

- 8 1. It hereby approves the submission of the Elder Health Care budget for year four.
- 9 2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman  
10 and any designated Official are hereby authorized to negotiate and execute  
11 contracts associated with this grant and to expend funds when received.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH.  
13 Day of JUNE, 2000 at a meeting at which a quorum was present with a vote of 2,005.5 FOR; -0-  
14 AGAINST; -0- NOT VOTING; and 160.0 [06] ABSENT, pursuant to the powers vested in the Council  
15 by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).


