1 WHEREAS, the Tohono O'odham Legislative Council has approved a three year proposal in the 2 total amount of \$1,751,668.00 for the Department of Human Services, Division of 3 Alcohol/Substance Abuse Program to expand substance abuse treatment in targeted 4 areas of need; and 5 WHEREAS, the Department of Human Services through the Division of Alcohol and Substance 6 Abuse is submitting for the reapplication of the third year for FY 2001. 7 NOW, THEREFORE, BE IT RESOLVED: 8 1. That the Tohono O'odham Legislative Council does hereby approve for 9 Reapplication of the third year proposal in the budgeted amount of \$580,956.00, 10 to establish expanded substance abuse treatment services and authorizes in 11 accordance to the attached grant and the third year annual budget. 12 2.
