1	WHEREAS,	the Tohono O'odham Nation is a Federally recognized Indian Nation governed by its
2		own laws, ordinances to conduct its own internal affairs, and administer its own Law
3		Enforcement Department; and
4	WHEREAS,	on October 18, 1999, the Arizona Peace Officer Standards and Training Board (AZ
5		Post) indicated that Tohono O'odham Police Officer Russ E. Jock's certification as a
6		AZ Peace Officer would be revoked if he did not meet the U.S. Citizenship
7		requirement of the AZ Post; and
8	WHEREAS,	Russ E. Jock is an enrolled member of the St. Regis Mohawk Tribe, a federally
9	:	recognized Indian Tribe located in the countries of the United States and Canada;
10		and
11	WHEREAS,	the Government of the St. Regis Mohawk asserts that they are dual citizens of the
12		United States and Canada in accordance with the provisions of the Jay Treaty of 1794
13		and the Immigration and Nationality Act of 1952.
14	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the
15		assertion of the St. Regis Mohawk tribe's position on Dual Citizenship.
16	BE IT FUR	THER RESOLVED that the Tohono O'odham Legislative Council supports and
17		encourages Russ E. Jock's efforts to maintain his AZ Post Peace Officer Certification,
18		in recognition of tribal sovereignty and tribal jurisdiction.
19	BE IT FINA	LLY RESOLVED that the Arizona Attorney General's Office carefully reviewed the
20		Tohono O'odham Nation's position on behalf of Russ E. Jock consistent with Federal
21		Indian Law, and the provisions of the Jay Treaty of 1794 and the Immigration and
22		Nationality Act of 1952.
23	The foregoi	ng Resolution was passed by the Tohono O'odham Legislative Council on the <u>19TH.</u>
