4		including a one-time per capita distribution of \$2,000 to each member of the Nation
5		enrolled on June 28, 1997 (the "Initial Per Capita Distribution"); and
6	WHEREAS,	pursuant toResolution97-451, theLegislativeCounciladoptedanInitiativeFunding
7		and Implementation Plan (the ``FIP") which authorized the establish ment of set-aside
8		accounts for the Initial Per Capita Distribution and other Initiative measures, and set
9		certain conditions on the expenditure of funds from such accounts; and
10	WHEREAS,	by Resolution 97-478, the Legislative Council approved the transfer of funds from the council approved the council
11		Desert Diamond Savings Account to certain designated set-aside accounts
12		established at Bank of America Arizona, including the sum of \$41.5 million to set-
13		aside account no. 3030425-1067524 for the Initial Per Capita Distribution (the "Per
14		Capita Account"); and
15	WHEREAS,	three of the conditions to expenditure of the Per Capita Account specified in the FIP
16		are (1) approval by the Secretary of the Interior of a per capita distribution plan (the
17		"Revenue Allocation Plan") pursuant to the requirements of the Indian Gaming
18		Regulatory Act, 25 U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative Council of a
19		$Certification \ of Eligible \ Members \ submitted \ by \ the \ Enrollment \ Office \ and \ based \ upon$

27		Area Office by the Secretary of the Interior; and

RESOLUTION NO. 2000-299 (Accepting Certification of Eligible Members and Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative) Page 2 of 4 1 WHEREAS, by letter dated December 18, 1997, the Area Office approved the Revenue Allocation 2 Plan with respect to the Initial Per Capita Distribution and disapproved the Plan with 3 respect to the Biennial Per Capita Payments; and 4 WHEREAS, an agreement with Bank of America has not yet been finalized for the establishment 5 of the restricted accounts which is required as a condition to disbursement of the 6 Initial Per Capita Distribution to such accounts for Minor Eligible Members; and 7 WHEREAS. pursuant to Resolution Nos.97-525, 98-010, 98-037, 98-084, 98-128, 98-192, 98-207, 98-8 278, 98-316, 98-360, 98-431, 98-478, 98-505, 99-006, 99-041, 99-081, 99-142, 99-201, 99-9 312, 99-363, 99-422, 99-478, 99-563, 99-635, 2000-005, 2000-037, 2000-085, 2000-148, 2000-177 and 2000-225, the Legislative Council accepted and approved Certifications 10 of Eligible Members for the Initial Per Capita Distribution, and disbursements have 11 12 been made to such members: and 13 WHEREAS, the Enrollment Office has filed with the Legislative Council a Certification of Eligible 14 Members listing 52 adult members who are eligible for receipt of the Initial Per 15 Capita Distribution; and WHEREAS, all conditions under the laws of the United States and the Nation have been satisfied 16 17 to permit the disbursement of the Initial Per Capita Distribution to the members 18 listed in the Certification of Eligible members. 19 NOW, THEREFORE, BE IT RESOLVED THAT: 20 1. The Tohono O'odham Legislative Council hereby accepts and approves the Certification of Eligible Members, in the form attached hereto. 21 22 2. The Legislative Council authorizes (a) the transfer of the sum of \$104,000.00 from the Per Capita Account to the special checking account no. 252-350-324 23 established at Bank of America Arizona (the "Per Capita Checking Account"); and 24 (b) upon the joint signature of the Chairman and Vice Chairman of the Nation, 25 issuance of a check on the Per Capita Checking Account in the amount of (i) \$2,000 26 to each Eligible Member residing in the United States and listed in the attached 27 Certification of Eligible Members and (ii) \$1,400 to each Eligible Member residing 28
