

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(In Support of Judicial Services FY 2000, Budget Modification #1)**

RESOLUTION NO. 2000-305

1 WHEREAS, the Tohono O'odham Nation, through the Judicial Services has been successfully
2 providing services and assistance to the Tohono O'odham; and
3 WHEREAS, the Judicial Services has a final allocation increase for FY 2000, in the amount of
4 \$4,290.00; and
5 WHEREAS, the FY 2000 Judicial Services budget modification #1 also reflects a line item increase.
6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council supports the
7 Judicial Services budget modification #1 reflecting the FY 2000 final allocation in the
8 amount of \$275,058.00.


9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
10 of JULY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0- AGAINST;
11 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of
12 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
13 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
14 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
