3	WHEREAS,	the Johnson-O'Malley Program supplements the Gila Bend Unified School District
4		#24, Indian Oasis Baboquivari Unified School District #40, as well as the Tohono
5		O'odham Early Childhood Head Start Program; and
6	WHEREAS,	as a result of an in-house modification, involving pass through line items 750 and 810,
7		the total amount reflecting Indirect Cost has decreased, from \$234,105.90 to
8		\$229,825.57; and
9	WHEREAS,	the FY 2000 allocation of Direct Funds in the amount of \$149,658.00 and 94 savings of
10		\$72,309.95, is not affected and remains as is.
11	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the
12		Johnson-O'Malley Budget Modification #3, reflecting a decrease of \$4,280.33 in
13		Indirect Cost.
